




Include a contacting section

- All relevant material consolidated into headings








- Allows for tenants to turn in paperwork online










Can I get evicted if I can't pay rent because of COVID-19?

In many cases, no you cannot. The Centers for Disease Control and Prevention (CDC) has temporarily halted evictions for most Americans due to the coronavirus pandemic until June 30, 2021.

moratorium is lifted.

The CDC moratorium was most recently scheduled to expire on March 31, 2021, but was extended in March.

What is Section 8?

An eviction is when a landlord who owns a property removes a tenant who is occupying that property. A formal eviction requires the tenant and landlord to go through a legal process.

The term section 8 is usually used to describe the Section 8 Housing Choice Voucher (HCV) programs.

Will affordable housing cause too much traffic?


No, people who live in affordable housing own fewer cars and drive less. Two-thirds of renters and over three-fourths of the households living below the poverty line own no vehicles or only one, car, compared to 54 percent of all households and 44 percent of homeowner households. With lower car ownership rates come fewer trips, and fewer accurant auto commutes, the Matropolitan Transportation Commission found in the 1000s that low income





